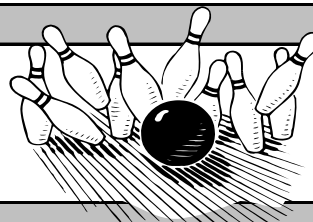

Rules

Bowlers will be bowling 6 games across 6 pairs. (In case of a tie a one-ball roll off will determine the winner; if the bowlers are still tied after one ball then they will switch lanes until the tie is broken).

Lane rotation will be determined before the start of scoring once the number of pairs in play is determined.

The bracket will be based upon the amount of cashers needed to create a typical bracket. (Ex: If there are 6 cashing spots it will be a 4 bowler bracket; if there are 12 cashers then it would be an 8 person bracket.) Maximum bowlers in the bracket will be 16. The remaining cashers will be paid based on total six (6) game pinfall. Cashing Ratio is 1 in 5

Bracket Finals

Top seed will bowl lowest seed, second seed will bowl second lowest seed, etc. The finals will then progress as a typical bracket format. (In case of a tie a one-ball roll off will determine the winner; if the bowlers are still tied after one ball then they will switch lanes until the tie is broken).
